O RUMO DO FUMO 2024

REGULATION

RESIDENCY PERIODS (one per project)

- 5 to 30 August 2024, with an informal public presentation on 30 August;
- 30 September to 25 October 2024, with informal public presentation on 25 October

PROJECT ELIGIBILITY (applicable at the time of the residency)

- The project must be an original work, in the process of being created and yet to be premiered, in the field of Dance and/or Performance;
- Each applicant with choreographic authorship in the project must have a maximum of 3 creations presented in a professional context.

APPLICATIONS

- Applications will only be accepted until **1 May 2024** at 17:59 (Lisbon time zone: GMT +0), submitted using the duly completed application form, which includes acceptance of the Regulations and Privacy Policy;
- Applications will not be accepted by e-mail;
- Full application in **Portuguese or English**;
- The results will be announced to each applicant by email from 10 June 2024.

SUPPORT FOR SELECTED PROJECTS

- Production support grant of €1,000 (one thousand euros) per project;
- Two sessions of artistic accompaniment to the project by artist(s) from O Rumor do Fumo;
- Organisation of a final informal public presentation at Espaço da Penha;
- Compensation for travelling, accommodation and food expenses of €600 (six hundred euros) to be divided between the two supported projects, subject to analysis by O Rumor do Fumo. Compensation applicable to non-Lisbon residents, upon submission of proof of expenses (invoices);
- The organisation of travel, accommodation, insurance and medical assistance during the period of residence is the responsibility of each applicant;

- Support for communication and publicising the project through digital channels and national and international e-mailing by O Rumo do Fumo.

Note: In the case of selecting an artist/structure with tax headquarters in a foreign country, it may be necessary to provide a declaration 21-RFI and declaration of tax residency, both issued in the current year. By applying to O Rumo do Fumo's 2024 Residency Programme, the artist/structure acknowledges that, depending on the country in question or failure to submit the requested documentation, the withholding tax may be up to 25%.

CONDITIONS

- Mandatory mention in the project's promotional materials: "Support for creation through Residency Programme - O Rumo do Fumo" or in the "Support" section of the artistic file;
- Inclusion of O Rumo do Fumo logo in the project's promotional materials, whenever possible.

STUDIO

- 100m² with wooden floor with air gap and black linoleum;
- Mirror: 6 metres long by 2 metres high;
- Sound system: 2 amplified speakers, 1 subwoofer, 1 mixing desk, 1 mini-jack cable.

- Dining area with microwave and fridge;
- Access to the Documentation Centre of Forum Dança upon request and availability;
- Wireless internet access and printer.

Artists in residence must comply with Espaço da Penha's health and safety rules while on its premises.
